

Abuse Services

In an instance of abuse where there is immediate danger to you or another individual 911 or the local police or sheriff's office should be notified. If you suspect that abuse is occurring or you are being abused and are not in immediate danger the local Department of Social Services should be contact to begin an investigation and protect the victim(s). If you or someone you know is remaining in an abusive situation because of a pet most shelters and domestic abuse services can assist in removing the pets as well.
